4. Trimming: Supply size: 8%" x 111%". Trim size 8%" x 107%". Trimming of oversized inserts will be charged at cost. Keep live matter ¼" from trim edges and %6" from gutter trim. Book is jogged to foot. Trims %" from head, face and foot plus %" gutter grind.

- 5. BRCs:
 - a) Pricing: Contact your sales representative for prices.
 Non-commissionable.
 - b) BRC Specifications: 3½" x 5" minimum to 4¼" x 6" maximum; perforated with ½" lip (from perforation) for tipping/binding. Add ¾" for foot trim. Cardstock minimum: 75# bulk or higher.
- Quantity: Full run 6,000 (estimated). Exact quantity will be given upon Publisher's approval of insert, or call Publisher prior to closing date.
